This announcement is made pursuant to Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

Datang International Power Generation Co., Ltd. (the “**Company**”) announces that, according to the Company’s preliminary statistics, as of 30 June 2022, the total on-grid power generation of the Company and its subsidiaries amounted to approximately 114.8192 billion kWh, representing a decrease of approximately 8.18% on a year-on-year basis. Among which:

The major reasons for the change in on-grid power generation of the Company include: affected by the pandemic, in the first half of the year, the electricity demand in some areas where the Company's generator sets are located has weakened. Besides, the fuel cost of thermal power units continued to run at a high level, and the Company's thermal power generation decreased year-on-year.

As of 30 June 2022, the average on-grid tariff of the Company was RMB457.81 per MWh (inclusive of tax), an increase of 16.85% year-on-year. In the first half of 2022, the market-based transaction volume of electricity of the Company was approximately 97.617 billion kWh, accounted for approximately 85.03% of the total.
